

<b>Bolivia</b> <i>Customs Information</i>	
<b>Documents Required</b>	<ul style="list-style-type: none"> <li>➤ Valid Passport</li> <li>➤ Inventory (original and four copies) in Spanish without values</li> <li>➤ Insurance Policy (original and two copies)</li> </ul>
<b>Customs Regulations</b>	<ul style="list-style-type: none"> <li>✓ CUSTOMER'S PRESENCE IS REQUIRED FOR CUSTOMS CLEARANCE</li> <li>✓ Duty-free entry for <b>foreign diplomats</b>.</li> <li>✓ <b>Bolivian diplomats</b> returning to Bolivia are not entitled to duty-free exemptions.</li> <li>✓ <b>Non-diplomats</b> can import used household goods and personal effects, but they are subject to duties and taxes</li> </ul>
<b>Motor Vehicles</b>	<ul style="list-style-type: none"> <li>▪ CUSTOMER'S PRESENCE IS REQUIRED FOR CUSTOMS CLEARANCE</li> <li>▪ Taxes and duties apply</li> <li>▪ Authorization <b>MUST</b> be obtained prior to shipping from SGS or Inspectorate for vehicles of F.O.B. value over \$12,000</li> <li>▪ Vehicle must have original steering wheel on left side</li> <li>▪ Vehicle must be no more than 4 years old</li> <li>▪ Diesel powered vehicles cannot exceed 4000 CC (4.0 L)</li> </ul> <p>Documents required:</p> <ul style="list-style-type: none"> <li>➤ Commercial Invoice</li> <li>➤ Certificate of driving conditions, proving that the vehicle is in good condition</li> <li>➤ Insurance Policy (original and two copies)</li> <li>➤ Certificate of Origin</li> <li>➤ Verifying Certificate (for non-diplomatic vehicle shipments)</li> <li>➤ Description of car (make, year, model, etc.)</li> <li>➤ Title</li> <li>➤ Registration</li> </ul>
<b>Pets</b>	<ul style="list-style-type: none"> <li>✓ Health Certificate and inoculation required</li> <li>✓ Most pets can be imported provided the shipper has a certificate of health and recent proof of rabies vaccination.</li> <li>✓ Importer must be present for clearance.</li> <li>✓ May be subject to payment of 32% duty.</li> </ul>
<b>Liquor</b>	<ul style="list-style-type: none"> <li>➤ All liquor within a shipment will be subject to duty and tax. Must present an inventory with exact number of bottles.</li> <li>➤ Importer's presence is required.</li> <li>➤ Subject to payment of 42% over CIF value</li> </ul>
<b>Dutiable / Restricted Items</b>	<ul style="list-style-type: none"> <li>✓ New items (invoice required)</li> <li>✓ Alcoholic beverages and tobacco products</li> <li>✓ Food (Phytosanitary Certificate required)</li> <li>✓ Medicine</li> <li>✓ Plants (Certificate of Sanitation)</li> <li>✓ Carpets</li> <li>✓ Precious metal objects, jewelry and coins</li> <li>✓ ALL OF THE ABOVE REQUIRE AN IMPORT PERMIT</li> </ul>
<b>Prohibited Items</b>	<ul style="list-style-type: none"> <li>➤ Weapons, ammunition and explosives</li> <li>➤ Drugs and narcotics</li> <li>➤ Pornographic material</li> </ul>
