Office Jets and Work Stations		The owner of these types of machines must be present at the Ministry of Interior in order to sign a statement saying that he/she will not be selling this machine, give it away or dispose of it in any way as well as that he/she will be the only person to be using and operating this machine. After signature of this statement, it will then be forwarded to the Ministry of Interior to get permission for the goods to enter the country. These items are subject to approval or refusal.	
Oil and any other paintings, mounted photographs, mounted posters and prints, sculptures and statues, dried-pressed flower collections Butterfly collections		Items to be approved by the Ministry of Culture before entering the country. A minimum of one week is needed for approval and will sustain a charge of minimum US\$ 175. These items are subject to approval or refusal.	
Fumigation of imported and exported wooden crates	The Egyptian Government adopted ISPM-15 (International standards for Phytosanitary Measures Publication 15) Guidelines for Regulating Wood Packaging Material in International Trade (aka NIFM-15) to standardise the treatment of wood packing materials used for the transport of goods. Details of the requirements will be provided as soon as possible.
