<b>Removal Goods</b>	<ul style="list-style-type: none"> <li>➤ Inventory of Goods</li> <li>➤ Customs baggage declaration form</li> </ul>	Personal & Household effects are admitted free of duty and taxes provided they are: <ul style="list-style-type: none"> <li>➤ Owned by passenger at the time of his arrival in Fiji.</li> <li>➤ Are for personal use of himself &amp; his immediate family.</li> <li>➤ Are not intended for gift, sale, barter trade or exchange.</li> <li>➤ Are imported into Fiji within twelve months after the date of arrival of the passenger.</li> <li>➤ In the case of returning residents of Fiji have been owned and used by such passenger for twelve months prior to his departure for Fiji.</li> </ul>	The owner in the presence of a Customs Officer must sign the baggage declaration form.
<b>Diplomats' Removals</b>	<ul style="list-style-type: none"> <li>➤ Passport copy</li> <li>➤ Inventory of goods.</li> <li>➤ Custom baggage declaration form.</li> <li>➤ Diplomatic declaration.</li> </ul>	Duty and Tax free.	Diplomatic declaration to be signed by head of mission.
<b>New Furniture and Household Items</b>	<ul style="list-style-type: none"> <li>➤ Inventory</li> </ul>	Duty-free provided owned by passenger at time of his arrival in Fiji.	
<b>Wedding trousseaux</b>	<ul style="list-style-type: none"> <li>➤ Inventory</li> </ul>	As above.	
<b>Inheritances</b>	<ul style="list-style-type: none"> <li>➤ Inventory</li> </ul>	As above.	
<b>Works of art, antiques</b>	<ul style="list-style-type: none"> <li>➤ Inventory</li> </ul>	As above.	
<b>Precious metal objects, Jewellery</b>	<ul style="list-style-type: none"> <li>➤ Inventory</li> </ul>	As above.	
<b>Motor Cars, Motorcycles and Motor Scooters</b>	<ul style="list-style-type: none"> <li>➤ De-registration papers</li> <li>➤ Ownership papers</li> </ul>	Motor vehicles, motor cycles and motor scooters are subject to duty & VAT.	Valuation by customs based on current market value in Fiji.
<b>Caravans, Trailers</b>	<ul style="list-style-type: none"> <li>➤ Documentary evidence of ownership</li> </ul>	Subject to customs duty and VAT.	As above
<b>Alcohol</b>		Subject to duty and VAT.	
<b>Firearms</b>		<ul style="list-style-type: none"> <li>➤ Prohibited import except under license issued by commissioner of Police.</li> <li>➤ Subject to duty &amp; VAT.</li> </ul>	
<b>Narcotics (drugs)</b>		Prohibited except with written permission of Director of agriculture.	
<b>Pets (dogs and cats)</b>	<ul style="list-style-type: none"> <li>➤ Health certificate.</li> </ul>	Duty free entry. Subject to import permit from Director of agriculture.	Subject to strict quarantine regulations.
<b>Pornographic Books and Magazines</b>		Importation prohibited.
