Boats	<ul style="list-style-type: none"> ➤ Not subject to above emission rules. 	Duty Free if part of household goods, owned at least 90 days prior to import and not for resale.	
Wine and Alcoholic Beverages	<ul style="list-style-type: none"> ➤ Descriptive inventory. 	An individual 18 Years and older cannot bring in more than one (1) gallon (3.8 litres) of alcoholic beverages as an exemption or as a gift. Any amount of alcohol in excess of the exemption shall be seized and Destroyed.	Should not be considered for importing.
Firearms	<ul style="list-style-type: none"> ➤ List of firearms with serial numbers ➤ Bill of sale. ➤ Firearms registration. ➤ Firearms license 	Guam Law allows persons to import up to 4 legally authorized firearms and 1,000 rounds of ammunition for their own use.	Firearms loaded with household goods should be loaded at the door if loose loaded or in crate number 1 if crated to allow easy access for inspections.
Medicines and Narcotics	<ul style="list-style-type: none"> ➤ Must be properly identified. Only normal required quantities are acceptable, provided they are supported by a prescription or statement from personal physician. 	Narcotics listed under the Schedule I, II and III of the Controlled Substance Act are generally prohibited entry.	<p>Do not load with household goods and should accompany owner on arrival.</p> <p>Severe penalties imposed if imported contrary to law.</p>
