<b>Documents Required</b>	<ul style="list-style-type: none"> <li>✓ Passport (original)</li> <li>✓ Residence Visa and rental contract</li> <li>✓ Residence Permit</li> <li>✓ Work Permit</li> <li>✓ Descriptive Inventory (showing contents of all cartons - PBO "Packed by Owner" and misc. "miscellaneous" not acceptable)</li> <li>✓ House lease contract (copy) if available -Children Admission to school certificate (copy) if available</li> </ul>
<b>Customs Regulations</b>	<ul style="list-style-type: none"> <li>➤ <b>Returning Jordanians</b> may import used household goods and personal effects duty-free provided the goods have been used by the customer prior to import, be for the customer's continued use, and be consistent with the customer's standing.</li> <li>➤ <b>Used household goods</b> are subject to duty.</li> <li>➤ <b>Shipment</b> must arrive within six months of customer .</li> <li>➤ <b>All shipments</b> inspected.</li> </ul>
<b>Motor Vehicles</b>	<ul style="list-style-type: none"> <li>▪ Highly taxed, according to owner's immigration status.</li> <li>▪ Vehicles five years old or older not permitted.</li> </ul> <p>Documents required:</p> <ul style="list-style-type: none"> <li>✓ Registration</li> <li>✓ Triptique</li> <li>✓ License</li> </ul>
<b>Dutiable / Restricted Items</b>	<ul style="list-style-type: none"> <li>➤ CUSTOMERS ARE HAVING PROBLEMS CLEARING THE RESTRICTED ITEMS SHOWN BELOW THROUGH CUSTOMS AND SIGNIFICANT LOSS AND DAMAGE HAVE BEEN REPORTED.</li> <li>➤ Electrical appliances, radio sets, musical instruments and carpets</li> <li>➤ New and some used furniture</li> <li>➤ New items</li> <li>➤ Refrigerators, carpets, washing machines, microwave ovens</li> </ul>
<b>Prohibited Items</b>	<ul style="list-style-type: none"> <li>➤ Weapons and ammunition</li> <li>➤ Drugs</li> <li>➤ Alcoholic beverages</li> <li>➤ Wireless equipment (CB, walkie talkies)</li> <li>➤ *ALL PRINTED MATTER, BOOKS, PICTURES, RECORDS, FILMS, TAPES, SLIDES, MOVIES, VIDEOS, COMPACT DISCS, COMPUTER SOFTWARE, ETC. ARE SUBJECT TO CENSORSHIP AND CONFISCATION (MUST BE PACKED SEPARATELY FOR EASY ACCESS)</li> </ul>
