

Macau	Customs Regulations 2011
<i>Household Goods and Personal Effects</i>	<ul style="list-style-type: none"> <li>▪ <b>Shipper must be in Malaysia at time of clearance</b> as original passport is required. Items less than 6 months old are dutiable. All shipments are subject 100% inspection by Customs.</li> <li>▪ <b>Diplomats</b> are required to obtain duty free certificate from Ministry of Foreign Affairs in advance of shipment arrival.</li> <li>▪ <b>All video tapes/vcd's/dvd's</b> MIGHT be subject to censorship. Charges range from US\$1-US\$5 per piece.</li> <li>▪ <b>If shipment is routed directly to East Malaysia</b> ( Kuching, Kota Kinablu, Miri, Labuan) all electronic items must be listed separately stating Brand, Model, serial number, country of purchase and value.</li> <li>▪ <b>Shipments that contain solid wood packaging material</b> need to be either fumigated or heat treated at origin (ISPM15 compliant). <b>Failure to do</b> so could entail shipment being subject additional quarantine charges at port of entry.</li> </ul>
<i>Prohibited and Restricted Goods</i>	<p>Goods prohibited from entering Malaysia include:</p> <ul style="list-style-type: none"> <li>➢ firearms,</li> <li>➢ ammunition,</li> <li>➢ pornographic material, and</li> <li>➢ short wave radios.</li> </ul>
<i>Motor Vehicles (Autos and Motorbikes)</i>	<p>Except for diplomats importing any vehicle will be subject to Import Duty and Tax at varying rates.</p> <p><b>Contact JVK for more details.</b></p>
<i>Animals and Pets</i>	<ul style="list-style-type: none"> <li>▪ Most pets, including dogs, cats, and birds, can be brought into Malaysia but will be subject to one month quarantine.</li> <li>▪ The documents necessary at the time of import are a current health certificate (not more than 7 days old) and a current vaccination card</li> </ul>
