<b>Documents Required</b>	<ul style="list-style-type: none"> <li>✓ Passport for each family member /Consignee</li> <li>✓ Work Permit (for foreign nationals) or NOC from Investment Promotion Bureau, Govt. of Pakistan</li> <li>✓ Letter from employer stating that the Customer will be stationed in Pakistan for approximately three years (for foreign nationals)</li> <li>✓ Employer Certificate</li> <li>✓ Pakistan Nationals require a National Identity Card (copy)</li> <li>✓ Transfer of Residence Certificate</li> <li>✓ Inventory, descriptive showing contents of cartons and of each liftvan</li> <li>✓ Bank Guarantee required for all shipments loose in steamship container,</li> </ul>
<b>Customs Regulations</b>	<ul style="list-style-type: none"> <li>▪ <b>CUSTOMER/ACCOUNT MUST BE ADVISED BEFORE SHIPMENT MOVES.</b></li> <li>▪ CUSTOMER MUST BE IN COUNTRY AT TIME OF CUSTOMS CLEARANCE</li> <li>▪ Used household goods and personal effects are duty-free in reasonable quantity</li> <li>▪ New or used furniture need the following:               <ul style="list-style-type: none"> <li>✓ Form "A" Customs</li> <li>✓ Passport</li> <li>✓ Invoice/packing</li> <li>✓ Employee Certificate                   <ul style="list-style-type: none"> <li>▪ Above in case of foreign nationals and proof that returning national is returning permanently</li> <li>▪ Allowed under personal baggage or transfer to residence</li> <li>▪ Customer presence is required for clearance</li> </ul> </li> </ul> </li> </ul>
<b>Dutiable/ Restricted Items</b>	<ul style="list-style-type: none"> <li>➤ Duties apply to all electrical items, major appliances and new items (invoices/receipts required).</li> <li>➤ Duties also apply to tobacco products, perfumes, toiletries and foodstuffs.</li> </ul>
<b>Prohibited Items</b>	<ul style="list-style-type: none"> <li>➤ Alcohol (will be confiscated at port of entry)</li> <li>➤ Drugs</li> <li>➤ Firearms, weapons, explosives and ammunition.               <ul style="list-style-type: none"> <li>If imported must have Exemption Certificate from Ministry of Foreign Affairs Islamabad.</li> </ul> </li> <li>➤ Pornographic material and statues</li> <li>➤ Recorded VCR tapes and other movies</li> </ul>
<b>Motor Vehicles</b>	<ul style="list-style-type: none"> <li>▪ * Importation is allowed only to diplomats and Pakistani Nationals</li> <li>▪ * Duties apply. Varies from 10090 to value (cost plus freight)</li> </ul> <p>* Documents required:</p> <ul style="list-style-type: none"> <li>✓ Import Permit</li> <li>✓ Passport</li> <li>✓ Invoice/old registration book</li> </ul>
<b>Pets</b>	<ul style="list-style-type: none"> <li>✓ Health Certificate</li> <li>✓ Passport of owner required for import</li> </ul> <ul style="list-style-type: none"> <li>▪ Customer's presence is required for clearance</li> <li>▪ Allowed accompanied or as unaccompanied baggage</li> </ul>
