<b>Removal Goods - General</b>	<ul style="list-style-type: none"> <li>➤ Packing list in French.</li> <li>➤ Copy of a valid passport.</li> <li>➤ Certificate of change of residence / moving certificate.</li> <li>➤ Original rated bill of lading (no express release accepted) / AWB.</li> <li>➤ Original valued inventory in French dated, valued and signed by the shipper.</li> <li>➤ Invoice for the electrical and hi-fi appliances; and for all the items bought less than 6 months before the shipment's arrival.</li> <li>➤ Residence or work permit or letter from the employer explaining that the client is starting a new contract.</li> <li>➤ Non sale certificate (declaration stating that the shipper will not sell his / her HHG).</li> <li>➤ Insurance certificate.</li> </ul>	<ul style="list-style-type: none"> <li>➤ Used HHG's are duty free if they have been in the owner's possession and utilization for at least 6 months. Please note that they must not have any new wrapping on them. They must be used.</li> <li>➤ Customs only allow 1 fridge, 1 cooker, 1 deep freeze, 1 computer, 1 TV, 1VCR...per shipper and his / her family. Any additional ones will be taxed.</li> <li>➤ Satellite dishes are considered to be luxury items and are therefore taxed by customs.</li> <li>➤ Washing products / detergents enough for one month only are permitted.</li> <li>➤ Please note that almost all the removal shipment are opened and checked by customs.</li> </ul>	Documents have to be express mailed / couriered 15 days before the shipment's arrival in order for the shipper's employer to apply the possible duty free exemption certificate.
<b>Diplomats' Removals</b>	Same as above.		
<b>Motor Vehicles</b>	<ul style="list-style-type: none"> <li>➤ Original registration card.</li> <li>➤ Original Bill of Lading / Airway Bill.</li> <li>➤ Non sale certificate (declaration stating that the shipper will not sell his / her car within 2 years of importation).</li> <li>➤ Certificate of change of residence / letter of transfer.</li> <li>➤ Copy of passport.</li> <li>➤ Motor vehicle's invoice</li> <li>➤ Insurance certificate</li> </ul>	Vehicle older than 5 years is prohibited.	Please note that in order to avoid any delays, demurrage and storage charges due to the lengthy customs procedures for vehicles, we require a copy of the documentation at least 1 month before the arrival of the shipment.
<b>Prohibited Articles</b>		<p><b>Firearms and munitions</b> are permitted subject to authorization from territorial administration.</p> <p><b>Unlawful drugs.</b></p> <p><b>Alcohol:</b> only the mention of "fond de cave" is acceptable (maximum of 10 bottles) and duty free.</p>
