| <b>Customs Regulations</b>          | <ul style="list-style-type: none"> <li>➤ CUSTOMER MUST BE IN COUNTRY FOR CUSTOMS CLEARANCE.</li> <li>➤ All shipments must arrive no later than six months after Customer.</li> <li>➤ Shipments partially inspected.</li> </ul>   |
| <b>Motor Vehicles</b>               | <ul style="list-style-type: none"> <li>➤ New autos are dutiable.</li> <li>➤ Original Registration Card and declaration of value must be declared.</li> </ul>   |
| <b>Dutiable / Restricted Items</b>  | <ul style="list-style-type: none"> <li>➤ New electrical items and furniture are subject to payment of Customs duties and taxes</li> <li>➤ Invoices to prove more than six months old required</li> <li>➤ Home computers are not accepted as personal effects and will be subject to Customs duties and import taxes</li> <li>➤ Tobacco products</li> <li>➤ Cosmetics, toiletries and perfumes</li> <li>➤ Bicycles</li> <li>➤ New musical instruments</li> <li>➤ Provisions, fabrics and gifts</li> <li>➤ Audio, video and photographic equipment</li> </ul>                    |
| <b>Prohibited Items</b>             | <ul style="list-style-type: none"> <li>➤ Weapons (including toys) and ammunition</li> <li>➤ Birds, fish and trophies, including animal skins and ivory</li> <li>➤ Currency and securities</li> <li>➤ Plants, seeds, seedlings, bulbs, etc.</li> <li>➤ Unwrought precious metals and precious stones</li> <li>➤ Pornographic material</li> <li>➤ Gambling equipment</li> <li>➤ Insects, beeswax, condensed milk</li> <li>➤ Alcohol and other spirits are prohibited and should be sent separately</li> </ul>  |
